Opinion:

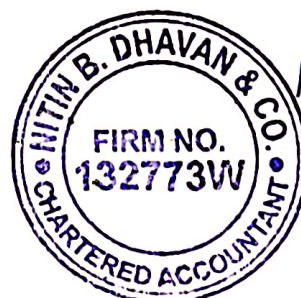
